

## The Case for ADRs- Debunking some Myths

One common misperception we have encountered is that investors using only American Depository Receipts (ADRs) are not as sophisticated as those that use only Ordinaries. As a manager using only ADRs we find that myth a little perplexing. After all, ADRs are exchange traded financial instruments, issued by banks to represent a foreign company's publicly traded stock and they trade just like US stocks. In other words, they simplify investing in international markets, but there's nothing unsophisticated about them. There are several other types of securities designed to achieve the same goal, such as American Depository Shares, Global Depository Receipts, Participatory Notes and securities of that ilk. The goal of each of these securities is to allow US investors (among others) to purchase securities from other global stock markets in dollar terms.

We see benefits to investing using ADRs. Specifically:

1. The selection of foreign securities that can be purchased using ADRs or similar securities is vast. Over 97% of International stocks with more than \$5 Billion in market capitalization are available in US exchanges as some variation of an ADR.
2. Investors can avoid commingled funds when investing using ADRs. International mutual funds are frequently used to simplify the process for US investors buying in dollars, but can lead to the loss of tax harvesting flexibility and transparency of fees and trading. ADRs allow investors to hold individual securities and readily see the fees they are being charged.
3. Liquidity is available for ADR transactions as many of the large trading firms will create them for you from their inventory of foreign stocks for a very modest fee.
4. ADR performance closely tracks the movement of the underlying securities and the currency conversion. Since there is an arbitrage opportunity between the local markets and the US ADRs, this match in performance is self enforcing and occurs naturally.
5. Investors can buy ADRs without the complexity of having to perform currency exchange. This simplifies the transaction to a single purchase, instead of a currency conversion and then a purchase.
6. Investors can buy ADRs without needing a foreign brokerage account. This eliminates the needs to abide by specific exchange rules and regulations for non-US exchanges, or deal with the time difference between the US and International Markets.
7. The sponsoring banks issue US statements to account for dividends and foreign withholding taxes that investors will want to claim. This simplifies accounting and paperwork for investors.

We have had some investors ask us if ADRs accurately track the underlying security, including the currency exchange differentials. In a word, yes, they do. To illustrate this, we have prepared the following example. If you had purchased two lots of \$10,000 worth of Nestle at the beginning of 2012; one in ordinaries including the currency conversion, and one in ADRs, the

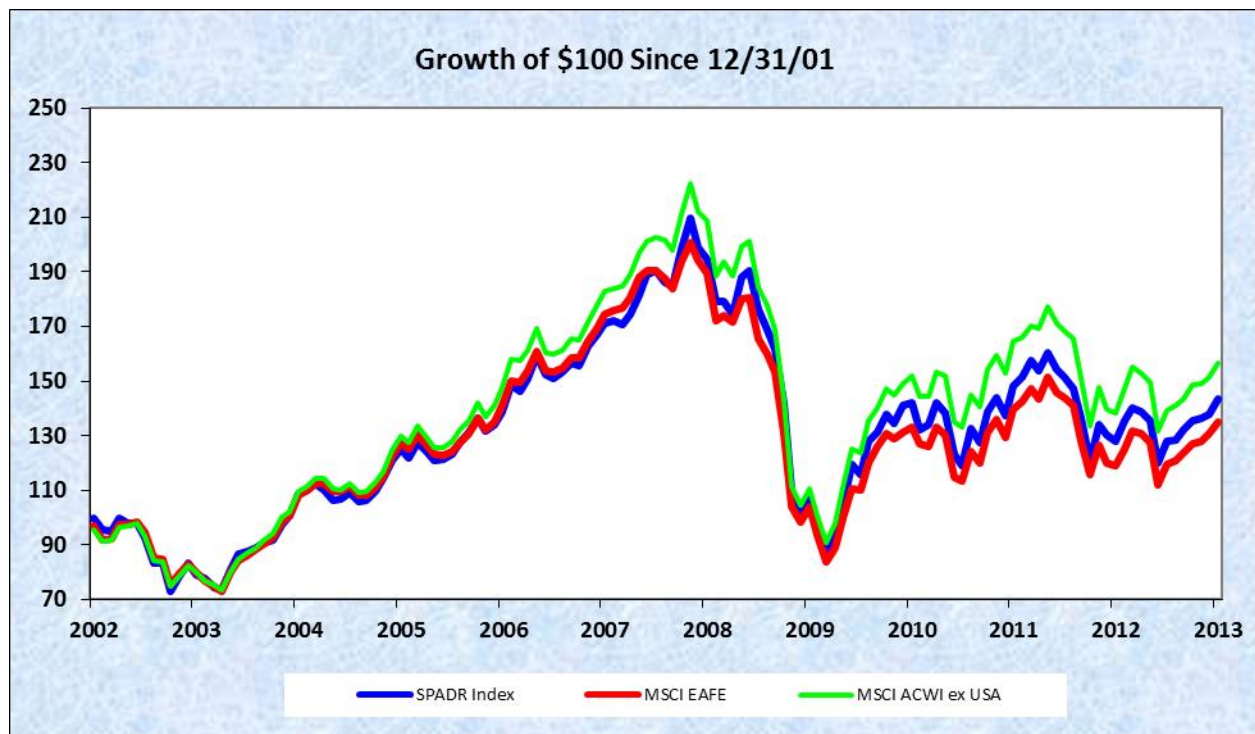


annual returns for both transactions were within about \$5, or 0.05% of each other. The example is presented below.

Example: A \$10,000 position in Nestle is initiated at the beginning of 2012 and closed out at the end of 2012. We will show the investment's return in two scenarios: 1) purchasing ordinary shares in the local market, and 2) purchasing ADRs in the U.S. market.

Local Market Investment	Investment in ADRs
<p><b>12/31/11:</b> Using the End of Day exchange rate, you would convert 10,000 USD into Swiss Francs at the bid rate of 0.9366, yielding CHF 9,366 (10,000 x 0.9366).</p> <p>You would then purchase shares of Nestle on the local market at a price of CHF 54.00/share, yielding 173.44 shares (CHF 9,366 ÷ CHF 54.00/share).</p> <p><b>4/26/12:</b> You would receive a dividend payment of CHF 1.95/share, yielding CHF 338.21 (CHF 1.95/share x 173.44 shares). We assume the funds from the dividends are not reinvested.</p> <p><b>12/31/12:</b> To close out the position, you would sell the 173.44 shares at a price of CHF 59.60/share, yielding CHF 10,337.02 (CHF 59.60/share x 173.44 shares). This would leave you with funds of CHF 10,675.23 (10,337.02 + 338.21).</p> <p>You would then convert these funds into USD at the ask rate of 0.9161, yielding \$11,652.91 (CHF 10,675.23 ÷ 0.9161).</p> <p>Your return on the investment would therefore be, <math>((\\$11,652.91 - \\$10,000) \div \\$10,000) = \mathbf{+16.53\%}</math> or <b><u>approximately +17%</u></b>.</p>	<p><b>12/31/11:</b> Using the end of day price, you would purchase Nestle ADRs at \$57.71/share, yielding 173.28 shares (<math>\\$10,000 \div \\$57.71/\text{share}</math>).</p> <p><b>5/23/12:</b> You would receive a dividend payment of \$2.11/share, yielding \$365.62 (<math>\\$2.11/\text{share} \times 173.28 \text{ shares}</math>). We assume the funds from the dividends are not reinvested.</p> <p><b>12/31/12:</b> To close out the position, you would sell the 173.28 shares at a price of \$65.17/share, yielding \$11,292.66 (<math>\\$65.17/\text{share} \times 173.28 \text{ shares}</math>). This would leave you with funds of \$11,658.28 (<math>\\$11,292.66 + \\$365.62</math>).</p> <p>There is no currency conversion necessary.</p> <p>Your return on the investment would therefore be, <math>((\\$11,658.28 - \\$10,000) \div \\$10,000) = \mathbf{+16.58\%}</math> or <b><u>approximately +17%</u></b>.</p>

For those that are still skeptical, we have included a chart below illustrating that the correlation between the S&P ADR index and both the MSCI EAFE and MSCI ACWI ex-US indexes is over 98%. Our experience has been that ADRs allow us a full slate of attractive investment alternatives that provide easy access to international stocks for our clients. While there may be a less representative list of options available for smaller cap investors, our experience indicates that for large cap investors, ADRs performance opportunities equal Ordinaries.
